Subject: National Resource Center Procedures Cancellation Date: January 31, 1999

The Restructuring and Reform Act (RRA) which was signed into law on July 22, 1998, makes dramatic changes in the procedures and methodologies of conducting examinations, collections, and numerous other functions of the Service. These changes have been enacted after extensive hearings and criticism of the Service and its employees for their mistreatment of taxpayers. Thus, Congress will closely monitor how these changes are being observed. Because of the extensive nature of these changes, the size of the agency, and expected public scrutiny, consistency of interpretation and implementation processes are crucial.

This Notice is to advise all offices of recently instituted procedures by the Chief Operations Officer (COO) to coordinate policy and program questions and ensure the uniform development of RRA positions. This Notice also sets forth Chief Counsel procedures to complement those procedures adopted by the COO.

## I. SERVICE COORDINATORS AND THE NATIONAL RESOURCE CENTER

Restructuring and Reform Act Coordinators (RRACS) have been selected at service center and district director offices. RRACS exist for several district/service center functions (CO, EX, CS, EPEO and ADJ). Initial training was furnished to the RRACS in a July 16, 1998, telecast. Their role is to receive and, to the extent they can, answer RRA questions arising within their functional area. Employees with RRA questions are being directed to forward their questions to the RRACS. They have been directed not to use other conventional

methods of obtaining guidance including guidance from district counsel. It is very important that RRA issues be elevated so that concerns can be identified early, and can be addressed on a consistent nationwide basis. In order to accomplish these goals, a specific procedure has been created for answering RRA questions.

If the RRAC is unable to answer a question, he/she will submit the question in writing to the National Resource Center (NRC). The NRC is made up of functional representatives from the Service and Counsel and its role is to answer questions submitted by the RRACS. Upon the NRC receiving a written inquiry, the inquiry will be forwarded to a member of the NRC having functional responsibility over the issue (this

member is referred to as the prime member) and at the same time to all other NRC members who may provide input to the prime. The prime member will coordinate as appropriate and reply to the RRAC within 48 hours (2 business days). If unable to meet the 48 hour requirement, an interim response will be furnished to the RRAC indicating the person working the issue, along with an anticipated completion date. The NRC will review on a routine basis (approximately weekly) all responses and if there is no objection to a given response, the question and response will be placed on an NRC intranet website.

## II. NATIONAL OFFICE CHIEF COUNSEL PROCEDURES

Peter Devlin, Deputy Assistant Chief Counsel (General Litigation) and Dan Wiles, Deputy Associate Chief Counsel (Domestic Field Service) represent the Office of Chief Counsel on the NRC. When Chief Counsel is determined to be the prime member for a particular question, the question will be referred to them. Peter Devlin (for Collection questions) or Dan Wiles (for all other questions) will directly answer the question, or will assign the question to the Counsel subject matter expert in the national office. A list of the subject matter experts is attached as Exhibit A.

The Counsel attorney responsible for answering the question will prepare the answer and will directly respond, generally by email to the requester, within the 48 hour period noted above. A copy of the response will be sent to Peter Devlin or Dan Wiles, as appropriate, who will share that response with other functional members of the NRC.

Other functional members of the NRC have received copies of the list of Counsel contacts and, therefore, may call upon the Counsel contact to assist the other function that is primarily responsible for NRC questions. The Counsel contacts will lend whatever assistance is necessary, remembering the 48 hour response time requirement. Counsel contacts should consider these assistance as informal advice, as the primary function would ordinarily formulate the response to the field RRAC.

## III. DISTRICT COUNSEL PROCEDURES

District counsel should not be receiving RRA questions from a district employee. All district issues will either be answered by the RRAC or the NRC. Obviously, it is not expected that district or regional counsel will reject questions from the client even if not in compliance with the NRC procedures. If the client calls but should have used the NRC procedures, it is expected that district or regional counsel will use the NRC procedures in providing advice to the client. That is, the district counsel should forward the question to the local RRAC, and if it cannot be answered at that level, to the NRC. A list of the RRACS is attached as Exhibit B.

If questions arise directly from field counsel with respect to the litigation changes that have been made by the RRA, field counsel may use the routine procedures that have been established with respect to national office advice. District Counsel are not

required to use the NRC procedures for litigation questions. To the extent that the question and response, however, are of general interest, the national office will share it with the NRC for dissemination on the NRC website.

By use of the NRC intranet website, district counsel are expected to familiarize themselves with the questions being asked and the responses provided. NRC procedures will terminate once a comfort level has been reached that the significant policy and program issues have been answered and that we are well on our way to ensuring uniformity of position. At that time district counsel advice procedures will be followed and district counsel are expected to be familiar with national positions that have been taken and disseminated. Of course, district counsel should submit any significant issue to the national office for assistance following termination of the NRC procedures.
