Subject: Tracking of Tax Court Documents **Cancel Date:** Upon incorporation into CCDM

Purpose

This Notice announces new procedures regarding the transmission of Tax Court documents to field offices. Commencing in May 2004, the Docket, Records, and User Fee Branch (Legal Processing Division) began e-mailing UPS tracking information electronically to field offices.

Background

The Docket, Records, and User Fee Branch receives documents daily on behalf of the Office of Chief Counsel from the Tax Court. Upon receipt, the branch sends these documents to field offices via UPS. Branch personnel sort and package the documents by location, then enter tracking information on the UPS website. Under prior procedures, if a field office did not receive a document, the office contacted the Docket, Records, and User Fee Branch, who then checked their records and the UPS website (http://www.ups.com/WebTracking/reference?loc=en_US) to determine the status of the UPS package containing the document.

New Procedures

New procedures have been adopted that permit field offices to track the UPS packages directly. Once branch personnel have entered the tracking information on the UPS website, the UPS website will automatically send an e-mail containing tracking information to the local office receiving the package. For each office location, an electronic mailbox has been set up to receive e-mails containing UPS tracking information. The mailbox for each location is named "&TCDocket-(location)." For example, the mailbox for Atlanta is named "&TCDocket-Atlanta." The list of mailboxes and associated locations is set forth on Attachment I.
