# Instructions Purpose of Form

Use Form 8812 to figure the additional child tax credit. This additional child tax credit may give you a refund even if you do not owe any tax.

This credit is in addition to the child and dependent care credit and the earned income credit that you may be able to claim.

## Who May Take the Additional Child Tax Credit?

You may be able to take the additional child tax credit if **both 1** and **2** below apply.

- 1. The amount on line 1 of the Child Tax Credit Worksheet on page 32 of the Form 1040 instructions or page 33 of the Form 1040A instructions is more than \$800.
- 2. The amount on line 7 of the Child Tax Credit Worksheet is more than the amount on line 11 of that worksheet.

### Line 1

If you worked for a railroad, include the following taxes in the total on line 1 of Form 8812.

- Tier 1 tax withheld from your pay. This tax should be shown in box 14 of your W-2 form(s) and identified as "Tier 1 tax."
- If you were an employee representative, 50% of the total Tier 1 tax and Tier 1 Medicare tax you paid for 1998.
