# Instructions

Section references are to the Internal Revenue Code.

## **Purpose of Schedule**

Use Schedule 6 for other claims, including refunds of excise taxes reported on:

- Form 720, Quarterly Federal Excise Tax Return, including section 4091(d) claims;
- Form 730, Monthly Tax on Wagering;
- Form 11-C, Occupational Tax and Registration Return for Wagering; or
- Form 2290, Heavy Highway Vehicle Use Tax Return.

## Claim Requirements

Generally, a claim must be filed within 3 years of the filing of the return to which the claim relates, or 2 years from when the tax reported on that return was paid, whichever is later.

Claims require the following information:

- 1. A statement why the refund is allowable.
- **2.** A statement that the claimant has any required supporting evidence.
  - 3. The dollar amount of the claim.
- The form number of the tax return to which the claim relates.
  - 5. Any additional information as required by regulations.

#### **Total Refund**

Add the amounts on lines 1 through 9 and enter the result in the total refund box at the top of the schedule.

# Section 4091(d) Claims

Caution: This claim cannot be filed with any other claim. See Schedules Attached on Form 8849.

If a registered aviation fuel producer bought aviation fuel on which tax was paid to the government, then a claim for refund of the tax may be made.

## Claimant

The registered producer that bought taxed aviation fuel is the only person eligible to make this claim.

## Claim Requirement

Attach all of the following information to Schedule 6:

- 1. Volume and type of aviation fuel.
- 2. Date on which the second producer acquired the aviation fuel included in the claim.
- 3. Amount of tax that the first producer paid to the government.
- **4.** If the fuel was sold, a statement certifying that the amount of the prior tax has not been included in the price of the fuel and has not been collected from the purchaser by the claimant.
- **5.** The name, address, and EIN of the person who paid the prior tax to the government.
- **6.** A copy of the First Producer's Report that relates to the aviation fuel covered by the claim.
- **7.** A copy of any Statement of Subsequent Seller that the second producer received with respect to that aviation fuel.

## How To File

Attach Schedule 6 to Form 8849. Write "Section 4091(d)" at the top of Form 8849 and on the envelope and mail to the address under **Where To File** in the Form 8849 instructions.

# Form 2290, Heavy Highway Vehicle Use Tax Return

A claim for refund may be made for the following:

- 1. A pro rata refund of the tax paid on Form 2290 for a vehicle that was destroyed or stolen before June 1 of any period (July 1–June 30) and subsequently not used during the period. To make a claim for a vehicle that is destroyed or stolen, the following information must be attached to Schedule 6:
  - a. The vehicle identification number (VIN),
  - b. Whether the vehicle was destroyed or stolen,
  - c. Date of the accident or theft, and
- **d.** Computation of the refund amount. See the line 4 instructions for Form 2290.
- 2. Any vehicle on which the tax was paid on Form 2290 if the vehicle was used 5,000 miles or less on public highways (7,500 or less for agricultural vehicles) during the period (July 1–June 30). The mileage limitation applies to the total mileage a vehicle is driven during a period regardless of the number of owners of the vehicle. A claim for this mileage refund cannot be filed until after June 30 of the period.

Attach Schedule 6 to Form 8849. Mail to the IRS at the address under **Where To File** in the Form 8849 instructions.

## Form 730, Monthly Tax on Wagering

A claim for refund may be made for the following:

- 1. An overpayment of tax. The following information must be attached to the claim.
- The facts involving the overpayment.
- The reason for claiming a refund.
- The date of payment and the amount of the tax.
- Whether any previous claim covering the amount involved, or any part, has been filed.
- A statement that you:
- **a.** Have not collected (whether as a separate charge or otherwise) the amount of the tax from the person that placed the wager on which the tax was imposed, or
- **b.** Have repaid the amount of the tax to the person that placed the wager, or
- **c.** Have the written consent of the person that placed the wager to the making of the refund (the consent must be attached to the claim).
- If the overpayment relates to a laid-off wager accepted by you, one of the above three statements must be attached for both the person that placed the laid-off wager and the person that placed the original wager.
- **2.** Credit for wagers laid off by you. The following information must be attached to the claim.
- The certificate described in Regulations section 44.6419-2(d).
- A statement that includes:
  - a. The reason for the refund,
  - b. The month in which the tax was paid,
  - c. The date of payment, and
- **d.** Whether any previous claim covering the amount involved, or any part, has been filed.
