- 1. Enter a valid account number which was provided by your TEC representative. Only orders with valid accounts will be processed.
- 2. Enter today's date.
- 3. Enter the name of the person to whom the order will be shipped.
- 4. Enter the daytime telephone number of the person receiving the order.
- 5. Enter the date the order is needed.
- 6. Enter the delivery location, be specific.
- 7. Enter the complete mailing delivery address where the order is to be shipped. P.O. Boxes are not preferred.
- 8. Enter city, state and ZIP code.
- 9. Give the last date order will be accepted (only products in back-order status after the date given will need to be reordered).
