Electronic submission of Form 7018-C can now be made from the IRS website at **www.irs.gov.** Click on the link for **Businesses**, then select **Online Package 1099**. Each item listed on this online order blank will have a maximum quantity of 1000 forms and 25 instructions that can be ordered. If you require a greater quantity than the maximum allowed, fill out the paper Form 7018-C and mail it to the appropriate Distribution Center.
