

In recognizing the important role tax professionals play in the federal tax system and the Service's ability to accomplish its mission, each filing season the IRS offers various products to assist our partners in serving their clients. This guide identifies the tax materials available to tax professionals for the upcoming filing season and how, when, and where they can be acquired. It also covers employer forms, prior year products, and how to obtain free and for sale products and electronic information.

Product and Filing Season Information

The Service is changing to meet the demands of our changing economy. This section highlights some of the tools used to communicate product and filing season information to our partners in the tax professional community.

Package X is No Longer Available

Individual tax products are available online (at www.irs.gov) and from other commercial and government sources. Publication 1796, IRS Tax Products (a CD-ROM equivalent to PKG X), is sold by both the Superintendent of Documents, under the Government Printing Office (GPO) and the National Technical Information System (NTIS), under the US Department of Commerce. Publication 1132, Reproducible Copies of Federal Tax Forms and Instructions (a hard copy equivalent to PKG X), is also sold by GPO.

Small Business CD-ROM

The Small Business Resource Guide CD-ROM for 2005 has enhanced navigation features to assist with your search efforts. We have included "drop-down" menus that allow you to see the topics in each of the sections. You will find a listing of CD related topics on the back panel of the cover. This interactive CD highlights all of the new tax law changes for 2005. It also includes all the business tax forms, instructions and publications to successfully manage a business. In addition, the CD provides a wide variety of web links to various government agencies, business associations and IRS organizations. The subscription option feature is your opportunity to join the SB/SE Mail List to receive valuable information that impacts the small business owners. Additionally, the CD now has links to the online "Rate the Product" feature and product update information, both available on the SB Homepage at **www.irs.gov/smallbiz**.

EITC Electronic Tools

Tax professionals play an important role in helping taxpayers understand and appropriately claim the Earned Income Tax Credit (EITC). Now, practically everything you need to know about the EITC is available right on your own computer - 24 hours a day, 7 days a week.

• Visit the **EITC Electronic Toolkit for Tax Preparers** at www.eitcfortaxpreparers.com for user-friendly listings on EITC eligibility requirements and full compliance information.

• Use the **EITC Assistant,** an interactive tool that lets you show your clients whether or not they qualify, and why. It's available in English and Spanish.

Finally, please let your clients know that they should respond immediately if the IRS contacts them for additional information. This may help to avoid EITC delays.

Responsibilities of Return Preparers

The importance of the role of income tax preparers is recognized in the Internal Revenue Code, which contains provisions that regulate conduct. These provisions include civil tax penalties that can be imposed on return preparers who:

- 1. Fail to meet disclosure requirements and certain administrative actions,
- 2. Engage in certain prohibited practices, or
- **3.** Understate a taxpayer's tax liability on any return or claim for refund.

For more information, see **Pub. 947**, *Practice Before the IRS* and Power of Attorney; **Circular 230**, Regulations Governing the Practice of Attorneys, Certified Public Accountants, Enrolled Agents, Enrolled Actuaries, and Appraisers before the IRS; IRS Notice 90-20, 1990-1 C.B. 328; Rev. Proc. 95-95, 1995-2 C.B. 457, IRS Sections 6060, 6109, 6662, 6694, 6695, and 7216; and related income tax regulations.

Privacy Act and Paperwork Reduction Act Notice. — The Privacy Act and the Paperwork Reduction Act require that when we ask you for information, we must first tell you our legal right to ask for the information, why we are asking for it, and how it will be used. We must tell you what could happen if we do not receive it and whether your response is voluntary, required to obtain a benefit, or mandatory under the law. As a member of the Tax Professional's Program, your response is voluntary to obtain a benefit: the tax items and tax information offered via this distribution program. If you do not submit the requested information, we may not honor your application to maintain your participation in the Tax Professional's Program.

You are not required to provide information requested on a form that is subject to the Paperwork Reduction Act **unless** the form displays a valid OMB control number.

Books or records relating to a form or its instructions must be retained as long as their contents may become material in the administration of any Internal Revenue law. Generally, tax returns and return information are confidential, as required by Internal Revenue Code section 6103.

The time needed to complete Form 3975 will vary depending on individual circumstances. The estimated average time is 3 minutes.


