Specially trained IRS staff can address tax topics unique to government entities such as, governmental employer responsibilities, and issues of payments to outside contractors.

Our offices, located throughout the country provide assistance through educational seminars and workshops at national and local levels focused on:

- employment tax withholding, reporting, and filing requirements, and
- information return reporting requirements associated with payments to vendors

Compliance

The Office of Federal, State, and Local Governments has responsibility for ensuring the Federal tax compliance of four distinct customer market segments: Federal agencies, State agencies, Local governments, & Quasi-governmental entities.

In addition to the taxpaying customer market segments, there are two other customer segments that are vital in serving our primary customers: government associations and government practitioners.

Because FSLG customers are usually exempt from Federal income tax, our compliance efforts are generally focused on employment tax and information return reporting.

FSLG works with the Social Security Administration (SSA) to educate government entities about Section 218 Social Security Agreements. These agreements govern social security and/or Medicare coverage for state and local employees. While IRS is responsible for administering and enforcing the tax laws, SSA processes and interprets these agreements and related coverage issues.

FSLG coordinates with other IRS offices such as Employee Plans, Excise Tax, and Taxpayer Advocate Service to better assist you in resolving your tax problems.

Federal Agencies

The Federal agency tax compliance group has the lead responsibility to identify and coordinate Federal agency issues. Due to the complex nature of these entities and their transactions, the Federal agency group was formed to address both the service needs and compliance aspects of this market segment. Federal Agency training seminars are conducted annually to provide updated training regarding various issues related to these government entities.



FSLG Area Offices

The office of Federal State and Local Governments (FSLG) is part of the Government Entities business unit of the Tax Exempt and Government Entities (TE/GE) Operating Division of the Internal Revenue Service. FSLG supports Federal agencies, quasi-government entities, state agencies, local governments and the U.S. Territories.
