## STATEMENT OF SEC CHAIRMAN WILLIAM H. DONALDSON

**Washington, D.C., Feb. 22,2005** - Statement of SEC Chairman William Donaldson concerning the IRS's announcement today regarding its executive stock option settlement initiative:
